- e) Certification Program Update (John) John spoke with the ASBO certification representative about logistics. There is a difference between accreditation and certification program. Right now we are running a certification program. If we are wanting to explore something else, we need to have a committee.

- a) KSSA Request for Joint Statement (Michael) School funding formula ends in 2027. KSSA and USA wanted to discuss a recommendation to the legislature or a joint statement from all organizations. KASBO is interested but would like to see the structure.
- b) USA Committee (John) GA called John. He is trying to get a group together to look at RNR to see if there are some suggestions we can make to the legislature.
- c) AEDG Membership Renewal Survey (John) Every 5 years they do a survey to membership about PD, staffing, membership levels, etc.
- d) Google Site vs. CVent (John) John has started building a google site instead of Cvent. He will bring more info in January.
- e) Policy Review Committee (John) We need to review reimbursements, travel expenses, etc. Need to expand the committee for the By Law review.
- f) Curriculum Development Stipend Ad Hoc Committee (John)
- g) School Bookkeeper Training (Debbie) Many new bookkeepers who need Activity Fund training. Possible way to expand

membership. Train the trainer option. Possibly do at same time as Fall Conference or a virtual meeting.

- h) 2024 Fall Workshop Site Manhattan or possibly another quote
- i) Fees (John)
 - i. Membership (increased from \$25 to \$50 last year)
 - ii. Vendor (Vendor increased from \$700 to \$900, Silver from \$1500 to \$1,700, Gold remained \$3,500, Premier remained \$7,500)
 - iii. ACE (increased from \$175 to \$200)
 - iv. Academy (\$150)
 - v. Fall Conference (\$150)

Consensus is to keep fees the same, with the understanding that we may need to reevaluate.
