Vision/Traction Organizer- Strategic Plan Update (John)

- 1. Strategic Planning organizer that was started last year in July.
- 2. The board had determined the core values and focus of the Board and KASBO centered around a 10-year plan.
- 3. We need to determine some steps for critical dates so we can update and notify people consistently of upcoming events, such as at certain times information goes out so many days prior to the event.
- 4. Over the next 90 days, there are several things to start and plan, Fall Conference checklist, Academy: Risk Management, complete PD planning for ACE, by-law review, Academy checklist, QuickBooks, develop comprehensive district surveys.
